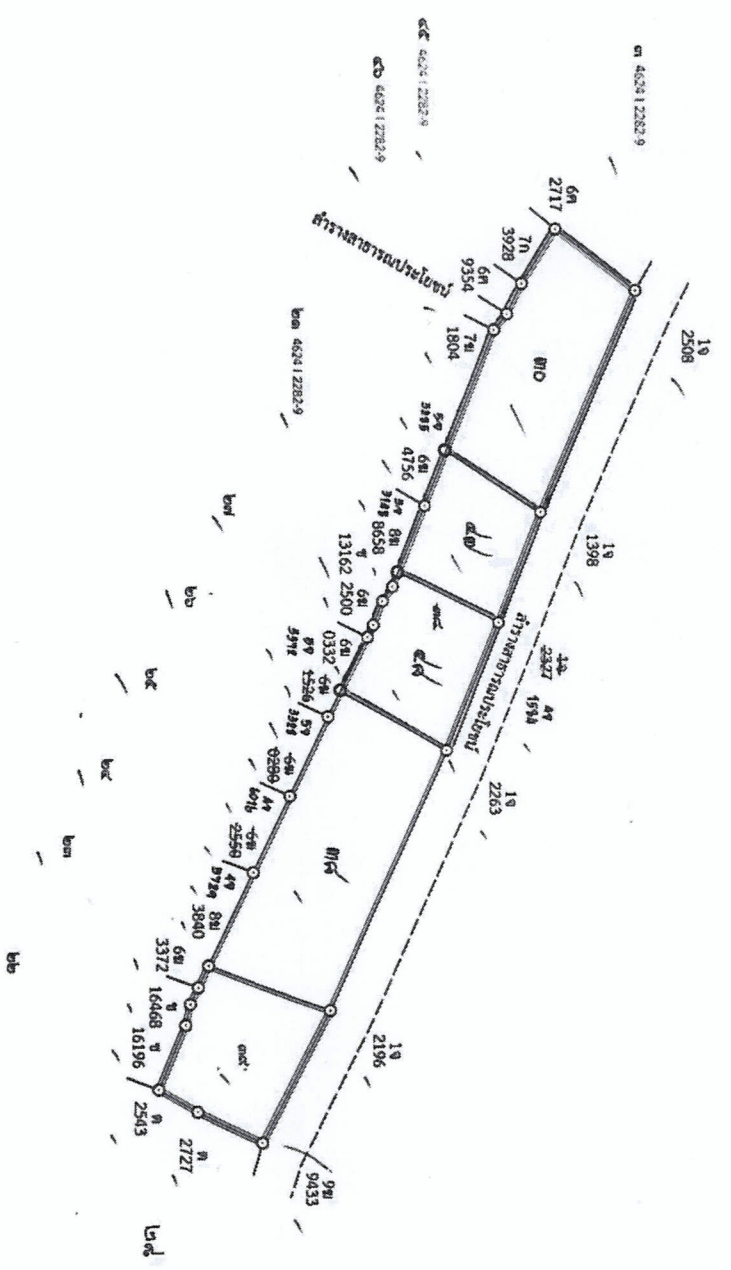

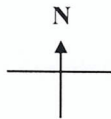

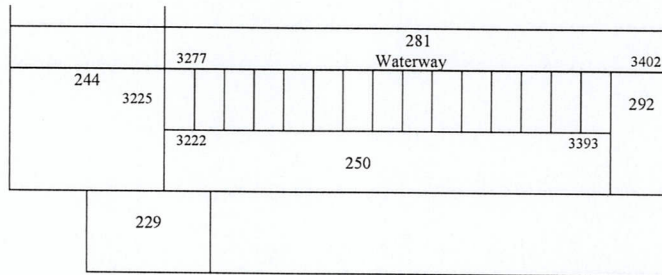
DIAGRAM OF THE LAND

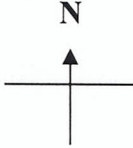
